Cookies are small text files stored on your computer or mobile device during your initial website visit. You can manage your cookie settings through your internet browser to opt out of cookies, delete stored information, and receive notifications when cookies are sent.

Privacy-Friendly Google Analytics

We use Google Analytics to analyze website visit and click behavior. Data is processed and stored by Google in the United States. We anonymize IP addresses, disable data sharing, and avoid combining Google services with Google Analytics.

Data Security

We take data protection seriously. Your data is stored both offline on our PC and encrypted online. Our computer is secured with effective technical measures, and our website employs a reliable SSL certificate.

Data Retention

We keep your data only as long as necessary to achieve its intended purposes. Legal obligations require us to retain administrative records, including invoices with address details, for seven years.
